Rules and Regulations of Spandana Super Singer, USA-2010.

1. Only participants from Indian origin community and residents of North America are eligible to participate in this competition for the Spandana Super singer, USA-2010 ("Program").
2. Children of Spandana office bearers and relatives and/or students of the judges of this Program will not be eligible to enter into MEGA FINALE of the Program. They are encouraged to participate in the program to donate and support the students though.
3. Only the first 100 eligible entries will be selected to participate in the training work shop at any location and SPANDANA reserves the right to close the entry of the Participants at a time convenient to SPANDANA. There is no limit to personal/online auditions though.
4. The intent of this competition is to nurture and give an opportunity to all those who want to become singers. Therefore those who have sung as solo singers for movies released either in India or out of India cannot participate in this competition.
5. Participants have by participating in this competition, agree to permit Spandana to televise, use the footage of the recorded material, printed material or photographs the performance of the Participants in the competition in any manner whatsoever it is concerned.
6. Spandana will not be liable for any non-selection of a Participant due to technical faults in the voice drops, video booth, mobile booths, internet or CD's & cassettes entries.
7. Selected Participants will have to be available at the next level of the competition to be held at a place and venue stipulated by Spandana, in case if the participant fails to attend on the date intimated then the participant shall be considered to be eliminated.

8. Spandana shall not be responsible for any cost towards, transport, travel, costume, boarding or lodging of the participant and that the participant shall have to bare the cost of the same.
9. The participant must be accompanied by their parent or legal guardian. Spandana Foundation ("SPANDANA") does not accept responsibility for parental supervision or guardianship for any Participants.
10. Participants must be of sound mind and should not be prevented from participating in the competition by any previous contractual obligation.
11. Spandana is not responsible for misplaced, lost or stolen articles of either the participant or the person accompanying the participants.
12. Spandana and contest sponsors assume no liability or responsibility in connection with the safety or performance of any contestant, and do not make nor are responsible for any warranty or representation with regard to event. Each winning contestant releases Spandana and contest sponsors from any responsibility or liability in connection with any loss, damage, injury, mental trauma, accident or death incurred in connection to the event.
13. No interference whatsoever by a parent or a legal guardian regarding the competition /Program and/or in the conduct of the competition/Program will be entertained by Spandana and any breach of this clause will automatically disqualify a Participant from entering and proceeding to further levels in the competition.
14. The Participants accompanied by their parent or legal guardian shall make themselves available as may be required by Spandana in connection with the competition on any day as per the time schedules including any reasonable delays and as intimated by Spandana from time to time.
15. Participants shall make no statements to the press or any media service regarding Spandana, the competition, or its operations and activities without prior written approval from Spandana.
16. The selection of the participants will be by a panel of predetermined judges. The decision of the judges and Spandana will be final. The participants hereby waive all rights to challenge the decision of the judges. Selected participants will have to enter into a separate contract with Spandana.
17. Songs containing vulgar or explicit sexual lyrics will not be allowed. Contestants who during their performance, use any obscene, offensive, sexual or otherwise inappropriate behavior or gestures, including without limitation those referencing or depicting violence, nudity or explicit activity - or which are not in the spirit of the contest or do not meet Spandana standards for any reason, as determined by Spandana will be disqualified from the competition.
18. Spandana shall reserve the right to eliminate the participant at any stage of the competition. Further Spandana reserves the right in their absolute discretion, to reject an entry and/or alter all or any part of the Rules and Regulations and that either the parents and / or the legal Guardian of the participant waive the right to dispute the decision of Spandana.

19. In case of a dispute SPANDANA's decision shall be final and binding on all the parties concerned.
20. No communication whether direct or indirect will be entertained by Spandana and any breach of this clause will automatically disqualify a Participant from entering the competition.
21. All personal details and information requested by Spandana by each contestant must be truthful, accurate and in no way misleading.
22. Spandana has the right at any time to request proof of identity and/or eligibility. Failure to provide such proof within a reasonable time could result in disqualification from the competition. Spandana reserves the right to disqualify any contestant from the competition or auditioning process in its sole discretion, should the contestant at any stage supply untruthful, inaccurate or misleading personal details and/or information or should the contestant be ineligible for the competition pursuant to these rules.
23. By submission of an application and entering into this contest, each contestant represents and warrants his or her compliance with these rules and regulations. No contestant will be permitted to audition unless he or she has acknowledged and agreed to these rules and regulations.
